Dubuque County Repeats

Spring is in the air, we hope it stays, and we are quickly heading into Iowa Summer. Along with the many activities that families and individuals enjoy, America's favorite pastime of baseball is in full swing (pun intended). American Legion Baseball in lowa had a challenging start to an early season due to unpredictable weather. Many of the post sponsored teams did not have the opportunity to play as many games due to some form of

precipitation or its aftermath on fields. Nevertheless, teams kept their resolve and The Department of Iowa had four Area Tournaments to determine which teams had their opportunity to play in the Department Tournament, May 4-5, 2019 in Sioux City.

The teams that played in the state tournament were: Ames (Ames Post #37), Peak Carroll County (Dedham Post #20), Dubuque County (Cascade Post #528, Dubuque Post #6, Dyersville Post #137, Epworth Post #650 and Farley Post #656), Johnston (Johnston Post #728), and Woodbury County (Sqt. Bluff Post #662). In what turned out to be great weather for baseball, Woodbury County and Dubuque County advanced to the state finals. Both teams received the chance to play Sunday at Lewis and Clark Stadium, home of the Sioux City Explorers. After persevering through the short rain delay, the game was called due to a 10-run mercy rule in the bottom of the sixth inning after Dubuque County sealed their victory. Dubuque County drove in their final run to make the score 13 to 3.

On Sunday morning Patrick's confidence and conviction as he gave his prepared speech capped off an amazing exhibition 1919 of talent at the finals.

The One-Hundredth One Annual Convention of The American Legion, Department of Iowa, will be held in Des Moines, Iowa, July 19, 20, 21, 2019. The Convention will be called to order at 4:00 p.m., Friday, July 19, in Ballroom Central and South of the Holiday Inn Des Moines Airport Conference Center in Des Moines, Iowa.

PURPOSE

The Convention is called for the purpose of:

1. Electing Department Officers for the ensuing year;

2. Ratification of Constitution and By Laws;

3. Selecting the place of holding the One Hundred and Second Annual Department Convention;

4. Selecting delegates and alternates to the One-Hundredth Annual National Convention; and

5. For the transaction of such other business as may be brought before the Convention.

REPRESENTATION

Representation will be by Post. Each Post is entitled to two delegates and two alternates, provided it has at least 15 paid up members by June 19, 2019. Each Post is also entitled to one delegate and one alternate for each additional 50 paid up members or a major fraction thereof, whose dues have been paid on or before June 19, 2019.

The vote of each Post will be equal to the total number of delegates to which it is entitled.

All Past Department Commanders of the Iowa Department of The American Legion, who are members in good standing in any Post in the Department, present and in attendance at the Department Convention, shall be entitled to all the privileges of a delegate to said convention, and entitled to a vote therein.

SELECTION OF DELEGATES

All Post delegates and alternates to the Convention will be selected at a regular meeting of the Post, or a special meeting called for that purpose.

Post Adjutants should give notice in writing to each member of the Post of the date, time, purpose, and place of such meeting, and the number of delegates to which it is entitled in the Convention.

Alternates have power to vote only in the absence of delegates, but have all other privileges of delegates.

Delegates should be chosen with care as they have the voting power of the Post on all questions brought before the Convention.

EXPENSES OF DELEGATES AND ALTERNATES

DEPARTMENT HEADQUARTERS

Department Headquarters will be in Room 298 of the Holiday Inn Des Moines Airport Conference Center in Des Moines, Iowa. Regular and routine correspondence should be sent as usual to the Department Headquarters, 720 Lyon St., Des Moines, Iowa 50309.

REGISTRATION AND HOUSING

Delegates, alternates and guests attending the Convention must register. A \$10.00 registration fee will be collected from all delegates, alternates and guests at registration.

Delegates, alternates and guests attending the Convention should address all inquiries relative to hotel reservations directly with the designated convention hotel(s).

CREDENTIALS FOR DELEGATES AND ALTERNATES

Credentials for delegates and alternates based upon the number to which each Post is entitled will be given at registration. All delegates, alternates and guests will be required to wear their badge in order to gain admittance into the Convention Hall.

OFFICIALS

Present Department and Post Officers, members of the Department Executive Committee, except Past Department Commanders, Officers of District and County organizations, unless selected as delegates and alternates to the Convention by their Post, have no privileges in the Convention except as guests of their respective delegations.

It is suggested that these officials be made members of the official Post delegation, as their experience will be exceedingly valuable to the delegation.

RESOLUTIONS

Any Post or accredited delegate to the Convention may submit resolutions embodying constructive suggestions for the welfare of The American Legion. They should be in duplicate, typewritten, and shall be turned into the Department Adjutant on or before July 5, 2019, in order that he may refer them to the Resolutions Assignment Committee. 



The convention is called for the purpose of electing officers for the ensuing year, amending the Department Constitution, Bylaws, and Standing Rules, receiving reports from Department Officers and Committees, electing delegates and alternates to attend National Convention, reports from members of National Committees, and the transaction of such other business as may be brought before it.

REGISTRATION:

Registration will be Friday, July 19th, from Noon to 7:00 p.m. and Saturday, July 20th, from 8:00 a.m. until 12:00 p.m. Registration fee is **\$10.00** for <u>Delegates</u>, <u>Alternates</u> and <u>Guests</u>. There is no registration fee for Junior Auxiliary members, but they MUST register. **Everyone is required to register at the Convention**. Registration fees <u>ARE NOT</u> accepted at the Department Office. <u>You must register</u> at the Auxiliary Registration Table at the Convention.

REPRESENTATION:

Refer to page 5 of the 2018-2019 Department Blue Book, Article VIII of the Department Constitution, Sections 2, 3, 4, 5 and 6:

Section 2. Each Unit shall be entitled to elect one (1) delegate and one (1) alternate, and one (1) additional delegate and one (1) additional alternate for each fifty (50) members or major fraction thereof, provided their current dues have been received by the Department Executive Director by **MAY 15th** of the current year. No alternate shall be entitled to a vote unless seated as a delegate.

Section 3. Members of the Department Executive Committee, all Past Department Presidents, District Presidents-elect, and incoming County Presidents, all of whom are in good standing in their local Units, shall be delegates at large to the Department Convention.

Section 4. Election of officers shall be held according to the Department Standing Rules. No member shall have more than one (1) vote.

Section 5: The Legislative Body of this Department shall be the delegates to the Department Convention to be held each year not less than two (2) weeks prior to the National Convention.


