- 2. **Liability:** Consistent with the Federal Tort Claims Act, 28 U.S.C. 2671-2680, and Article VII, Section 1 of the Iowa Constitution, Iowa Code chapter 669, the Iowa National Guard, and the State of Iowa, Department of Public Defense shall each be responsible for any and all liabilities, losses, damages, costs or expenses, incurred by another party to this lease as a result of the negligent acts occurring by another party.
- 3. **Permits and Licenses:** The lessee shall obtain all permits and licenses required for its activities at Camp Dodge. The State of Iowa shall not be responsible for the lessee's failure to obtain such permits and licenses or to comply with any other requirements imposed upon the lessee for the conduct of its activities.
- 4. **Compliance with Laws:** The lessee shall comply with all applicable laws, ordinances, rules and regulations. The State of Iowa shall not be responsible for the lessee's failure to comply.
- 5. **Internal Security:** The lessee shall be responsible for internal security of personnel and property within the areas assigned to it. The Lessee agrees that it bears responsibility for maintaining good order and discipline and compliance with applicable Camp Dodge regulations on the part of its personnel. The Lessee shall report immediately any violations of laws, ordinances, rules or regulations, including the Camp Dodge Regulations, to Training Center, Building W6, 515-252-4175 or Camp Dodge Security at Main Gate, Building S-63,515-252-4538.

- 6. **Vacating Premises:** On or before the date of the expiration of this lease or its termination, the lessee shall vacate the grounds and facilities assigned to it and restore the grounds and facilities to as good order and condition as that existed upon its arrival.
- 7. Cancellation by Adjutant General of Iowa: This lease may be canceled by the Adjutant General of Iowa at any time and for any reason. No claim for damages to the lessee from any such cancellation shall be asserted or maintained against the State of Iowa.
- 8. **Cancellation by Lessee:** Lessee reserves the right to cancel this lease at no cost to the United States Government. The Lessee will provide written notification to the Camp Dodge Training Center-Operations upon determination that the lease will be canceled due to lack of funds or other operational contingencies.
 - 9. **Assignment:** This lease is not assignable or transferable.
