## **COVID-19 & The Department of Iowa**

History repeated itself with a health crisis and nations found themselves united against an unseen common enemy, COVID-19. The global pandemic known as Coronavirus Disease 2019 has made life as we knew it dramatically different. In lieu of the evolving COVID-19 government proclamations, restrictions and recommendations, the Department of Iowa needed to respond. Several meetings were conducted through teleconferencing platforms, and the Department Executive Committee, with consultations from other state leadership commissions and committees, as well as National commission and committees, began postponing and cancelling state activities. All nine districts responded similarly with respect to spring conferences. other regular meetings, and of course the local post meeting.

The current state of affairs continues to challenge us all as individuals and an organization, however, it has not halted life, just slowed it down. As we move forward into what will become a new normal, we encourage you all to continue to stay safe, well and keep your wits about you as we do life together.

We wish to keep you updated as to the changes the Department of lowa has made thus far in this publication. For those of you who have adapted to technology, updates are posted more frequently through our Department website, Facebook, and the bimonthly electronic newsletter. We encourage you to visit the website and utilize its function as well as follow the Department of Iowa on Facebook. You can also sign up for the electronic newsletter through the website. Click on yellow button labeled "Subscribe" to sign up. Here are a handful of major changes within The American Legion both at the state and national level that have occurred due to COVID-19.

Department Convention: By unanimous vote of the

Department Executive Committee on May 2, the 2020 Department Convention, the commission and committee meetings preceding that convention, the Department Executive Committee meeting following that convention and the Color Guard competition during that convention have all been cancelled. The Holiday Inn will cancel all room reservations associated with the convention. There is no need for individuals to call and cancel rooms.

As a result of the cancellation of the convention, there will not be an election of Department officers. Also normally a vote of the convention delegates would be taken to determine the site for the 2020 convention. The resolution cancelling the convention specified that the Department Officers, both elected and appointed, would carry over for the 2020-2021 year. The Department Executive Committee also determined that the 2022 convention would be held at the Airport Holiday Inn in Des Moines with suggested dates of July 7-10, 2022.

Additionally all personnel appointed to the Department commissions and committees will carry over for the 2020-2021 year. Membership contests for the 2020 membership year will conclude on June 20, 2020. The resolution in its entirety that was brought before the committee may be found online www. ialegion.org.

National Convention: The National Executive Committee, by passing Resolution #3, has cancelled the 2020 National Convention scheduled for August 28-September 3 in Louisville, Kentucky. The 2026 National Convention will be awarded to Louisville, KY as a result. While the national resolution did not specifically state this, all national American Legion meetings up to September 30, 2020 have been cancelled. This includes but is not limited to:

during this COVID-19 pandemic that is sweeping our nation. I realize this has not been an easy time for any of us, for your Department Commander, it has well restricted my travels, in the process I have had to reshape my way of thinking and planning. So, my time has been spent on the phone making contacts with National Guard armory's and making buddy phone calls. Those phone calls have been uplifting not only to me but to those who I called just to greet and see how they were doing. They were very appreciative of my phone call and to hear a voice of someone who shared a genuine interest in how they were doing and to let them know their American Legion post shares the concern of how they were doing. Throughout all this pandemic and isolation, The American Legion Department Executive Committee plus other Department committees have met by conference calls or by zoom conferencing. You have read in my other article I have had the challenge be-coming somewhat technology  $wise, I\,am\,grateful\,I\,challenged\,myself\,and\,believed\,in\,myself$ that I could do things electronically with the computer. No doubt the zoom teleconferencing has been a blessing for your Department Executive Committee to be able to meet and conduct business. The hardest part of our meetings was for The D.E.C. to cancel The Department Convention being one of the major highlights of The American Legion Family. With that in mind all Department Officers, Department Commission, and Committee chairs, we remain the same for another year unless one chooses to resign. I know there will be other articles written about the cancellation of Department Convention so I will end on that part.

As you know my goal for the year is to be 100% in membership by June 20th. We are almost there however the last 7% is going to be the toughest to get and time is counting down, so I'm asking you if you have not paid your 2020 membership to your American Legion Post, I'm asking you to please do that now. As of May 8th, Department wide, your membership was at 93.31% just a hair over the 7% which is needed to realize 100% goal, that is approximately 928 memberships which have not been renewed for this 2020 membership year. Each report shows we are always behind last year. What is the problem it can't be deaths because we haven't lost that number, it simply those who need to be contacted to renew their membership and in doing so we need to ask why they haven't and what the reason being? When the member says I do not get anything out of my membership, why should I renew, who will miss me they say. Who will miss you?!! Every American Legion Member of an American Legion Post, County, District, Department and The National American Legion Organization. Those are ones who will miss you. Your membership is a voice, a vote, a game changer in your state's capital and in Washington DC. on issues concerning the benefits every deserving Veteran needs and should have. Your membership makes the American Legion voice strong and loud as we lobby and testify before The State House of Representatives, Senators and both houses in your Nation's Capital. The voice of your membership helps ensure we maintain and keep our Veterans Affairs Health Care Strong, yes, every membership is a number that counts. Also, each membership helps ensure The American Legion Service Office in the Iowa Federal Building is there when you need help in securing a medical claim or disability that comes from your time in the service doing what was ask of you.



### **Department Adjutant** John A. Derner

The COVID-19 pandemic has impacted the lives of us all. We have experienced challenges of varying degrees as a result

of this outbreak and we find ourselves striving to return to some sense of normalcy.

A few of weeks ago, I thought I was having a bad day. I had issues with work, complications at home, and difficulties with my family. I simply felt overwhelmed by all the disruption in my life.

Whenever I think I am having a bad day, I often reflect on the experiences of an acquaintance of mine, Larry Spencer. I met Larry through his advocacy for veterans in lowa. He is a Navy veteran who served from 1963-1985, retiring at the rank of Commander (O5).

On February 18, 1966 Larry was forced to eject from an aircraft over North Vietnam and was taken Prisoner of War. After spending 2,552 days in captivity, just shy of 7 years, he was released during Operation Homecoming on February 12, 1973.

Larry once spoke at one of our American Legion Department Leadership Schools. During his presentation he spoke of the mental and physical brutalities he and his fellow POWs endured. Near the end of the presentation, he made a statement which has stuck with me since.

After describing the events on the day of his release, he proclaimed that he has never had a bad day since. Some were better than others, but he never had a bad day since his captivity. And when I think I am having a bad day, those words from Larry Spencer help me put my own situation into perspective.

So, there I was, doing dishes in my home and feeling sorry for myself, when I realized that my bad day wasn't so bad after all. I could hear my three sons rough housing in the living room, I had just finished a good meal, and "What a Wonderful World" by Louis Armstrong came on the radio, almost as if on cue. I understood that compared to many, I had a pretty good day. It helped me to recognize all the joy and happiness in my life and all the blessings I

And then, as it often does, the rough housing by my boys in the living room turned into a fight. Had I still been in the mindset that it was a bad day, that probably would have made it worse. Instead, I found happiness in the fact that they are healthy enough to fight with each other, and faith that when it comes down to it, they will fight for each other.

Thanks to Larry Spencer and Louis Armstrong, I knew that my day wasn't so bad, and it still is a wonderful world. But it also reminded me that during this time, there are so many people in a much worse situation than my own.

There a many people in our country and in our own American Legion Family who are suffering. Some are unable to work and are struggling financially. Others are sick and are isolated from family and friends. Some have even died or have lost a loved one.

Some American Legion posts are suffering financially. We have been unable to execute many of our programs or serve our communities as we have in the past. Our members have been unable to gather and share the camaraderie that many of us so much enjoy and need. Sometimes we feel overwhelmed, frustrated and lonely.

It is at times like this, when our work can be the most important. Many of our American Legion posts, American Legion Auxiliary units, Sons of The American Legion squadrons, and American Legion Riders chapters are...

# **Department Service Officer**Shane Pankonen

Ever wondered what it would cost to modify your home? The Department of Veterans Affairs has programs to assist in these

programs.

The Specially Adaptive Housing (SAH) is a program to assist veterans and service members with qualifying service connected disabilities. These programs can help you purchase, build, or adapt a home to meet the lifestyle needs of the veteran or service member.

This SAH grant can be used to make your home more adaptive for enter and exit or your home, accessibility throughout the veteran's home.

Adaptations available are accessible to enter and exit the home, lower counter tops, lowered sinks, to make the bathroom completely wheelchair accessible, and widened doorways.

The veteran or service member must meet one or more of the eligibility conditions:

- 1.Loss or use of both lower extremities.
- 2. Blindness in both eyes.
- 3. Severe injury from a burn.

4.Loss of use of both upper extremities at or above the elbows.

Another type of grant the veteran or service member may be eligible for is the Specially Housing Adaptation Grant (SHA). This grant is used to increase access and mobility to accommodate his or her disability. This program helps assist the veteran.

The veteran or service member must meet one or more of the eligibility conditions:

1. Blindness in both eyes with 20/200 visual acuity.

- 2. Functional loss or loss of use of both hands, and extremities below the elbow.
- 3. Severe injury from a burn.

To seek disable housing grants to apply by submitting VA Form 26-4555 Specially Adaptive Housing or Special Adaptive Grant submit this to the VA or visit www.benefits.va.gov/homeloans/adaptedhousing.asp.

If you have any questions about these benefits you may contact a Paralyzed Veterans of America National Service Officer and we will be glad to assist you. Also, I may be contacted directly at 515-323-7544 for questions regarding this benefit or any VA benefits once the Federal Building has reopened.

## **Consolidated Post Reports**

The July 1 national target date for the Consolidated Post Report (CPR) is fast approaching. Although the national convention has been cancelled, it is still the National Commander's goal to have CPR submissions at 100%. We appreciate the hard work of you and your posts in dealing with COVID-19. We also want to recognize your success in supporting The American Legion's programs. National Commander Oxford wants every post to receive credit for their daily community

activities in support of veterans and their families. The CPR is an important gauge of efforts within your departments.

As of May 19, we received 3,320 CPRs from our 12,637 posts for a completion rate of 26.15%. Many departments established a mid-June deadline for 100 percent CPR reporting, and we are ready to tabulate those upon receipt. The Department of lowa has a deadline of June 15, 2020.

# Conducting Business During COVID-19

lowa nonprofit corporations are governed by the Revised lowa Nonprofit Corporation Act ("lowa Nonprofit Act"), which provides various means by which members and boards of directors are able to take action through virtual meetings and otherwise.

# Virtual or Telephonic Meetings of Members

The Iowa Nonprofit Act provides that the articles of incorporation or bylaws of a nonprofit corporation may provide that an annual or regular meeting of members is not required to be held at a geographical location if the meeting is held by means of the internet or other electronic communication technology in a manner pursuant to which the members have the opportunity to read or hear the proceedings substantially concurrent with the occurrence of the proceedings, vote on matters submitted to the members. pose questions, and make comments. lowa Code section 504.701(7). The same rule applies for special meetings of members. Iowa Code section 504.702(6). Notices of meetings may be communicated in person, by mail, other method of delivery, or by telephone, voice mail, or other electronic means. If these forms of notice are impracticable, notice may be communicated by a newspaper of general circulation in the area where published or by radio, television, or other form of public broadcast communication. When electronically transmitted, the notice needs to be sent to the member in a manner authorized by the member. Iowa Code section 504.142.

### Voting of Members – Alternatives to In-Person Voting and Voting by Virtual or Telephonic Meetings

There are various ways for members to vote without attending a meeting in person or a virtual or telephonic meeting. They include voting by written ballot or proxy as well as by a written consent.

### **Written Ballot**

Unless prohibited or limited by the articles or bylaws, any action that may be taken at any annual, regular, or special meeting of members may be taken without a meeting if the corporation delivers a written ballot to every member entitled to vote on the matter. A written ballot must (1) set forth each proposed action and (2) provide an opportunity to vote for or against each proposed action.

Approval by written ballot is valid only if the number of votes cast by ballot equals or exceeds the quorum required to be present at a meeting authorizing the action, and the number of approvals equals or exceeds the number of votes that would be required to approve the mater at a meeting at which the total number of votes cast was the same as the number of votes cast by ballot. All solicitations for votes by written ballot need to do all of the following: (1) indicate the number of responses needed to meet the quorum requirements; (2) state the percentage of approvals necessary to approve each matter other than election of directors; and (3) specify the time by which a ballot must be received by the corporation in order to be counted. Unless prohibited by the articles or bylaws, a written ballot may be delivered and a vote may be cast on that ballot by electronic transmission, including email. Iowa Code section 504.708.

#### **Proxies**

Unless the articles or bylaws of the corporation prohibit or limit proxy voting, a member or the member's agent or attorney in fact may appoint a proxy to vote or otherwise act for the member by signing an appointment form or by an electronic transmission (such as email). lowa Code section 504.715.

### **Written Consent**

Unless limited or prohibited by the articles or bylaws of the corporation, action required or permitted under the Iowa Nonprofit Act can be approved by the members of the corporation without a meeting of members if the action is approved by members holding at least 80 percent of the voting power. The action must be evidence by one or more written consents describing the action taken, signed by those members representing at least 80 percent of the voting power, and delivered to the corporation for inclusion in the minutes or filing with the corporate records. A written consent may be revoked by a writing to that effect received by the corporation prior to the receipt by the corporation of unrevoked written consents sufficient in number to take corporation action. A written consent may be submitted by a member through electronic transmission, which should include email. Iowa Code section 504.704.

The Iowa Nonprofit Act provides that unless the articles or bylaws provide otherwise, a board may permit any or all director to participate in a regular or special meeting by, or conduct the meeting through the use of, any means of communication by which all directors participating may simultaneously hear each other during the meeting. A director participating in a meeting by this means is deemed to be present in person at the meeting. Iowa Code section 504.821(3).

### **Action by Email**

Under the Iowa Nonprofit Act, a board to take action pursuant to a written consent signed by all of the directors. The written consent may be signed and transmitted electronically. The lowa Nonprofit Act does not expressly address email voting. Still, a board is able to use email communication for purposes of complying with the written consent requirements of the lowa Nonprofit Act. This means that each director needs to consent to the proposed course of action. An email vote in which not all of the directors vote in the affirmative is not effective under the Iowa Nonprofit Act. It needs to be unanimous. It is also necessary that each director "sign" the consent and deliver it to the association. Iowa Code section 504.822. Under the Iowa Nonprofit Act, the term "sign" is defined to include an "electronic signature." Iowa law defines an "electronic signature" very broadly to mean an electronic sound, symbol or process attached to or logically associate with a record and executed or adopted by a person with the intent to sign the record. With such a definition, a director could electronically "sign" a consent in a variety of ways. Iowa Code section 504.141.

Although emails can be very helpful to ensure quick communications to directors and to receive board of director approval on actions, it is extremely easy for such communications to be less formal than other types of communications. For example, a board chair might seek action from the board by asking the other directors what they think about a certain issue and treat it as board action if the other directors are supportive in their responses. If the proposed course of action is not clearly stated, there is risk of a dispute as to whether the board actually took action or what action was taken. Thus, it is important to present a proposal in a manner similar to how it would be presented in an in-person or telephonic meeting. An example would be sending the board the proposed resolution: "Resolved, that the board of directors approves the filing of the application for tax-exempt status with the Internal Revenue Service." Such email also might request that each director send a reply email stating "I hereby consent to the resolution" and, in order to meet the "sign" requirements, type the director's name below such statement.

Action by email is to be treated in the same manner as board action at an in-person or telephonic meeting from a record keeping standpoint. As a result, any email action should be included as part of the minutes of the nonprofit.

Finally, although it is possible to effectuate action of the board via email, it is important to recognize that this is not the preferable way for a board to act. A board is most effective when directors are able to consult and exchange views. This is accomplished through in person or telephonic meetings of the board. For this reason, email voting is often viewed as an alternative only when it is not possible to have the board meet either in person or by telephone.

Normally we would use this issue of the lowa Legionnaire to give you a report from the annual meeting of the American Legion of lowa Foundation. This year, that meeting like so many others could not be held on the original date due to the COVID-19 pandemic.

Our responsibility to

the grant applicants that depend on Foundations like ours to operate their programs stopped any thought of cancellation.

Virtual meetings are possible but the discussion around the decisions to be made at the Foundation annual meeting makes that exceedingly difficult.

The Foundation Directors spend several hours discussing how to best distribute the available funds. We typically have approximately \$100,000 to distribute but normally have almost twice that much in requests. Those are not easy decisions.

For now, the Foundation Board is waiting for the severity of the pandemic to subscribe to schedule our annual meeting. We are hoping to be able to schedule a meeting in the next 60 days but that depends on the response of the pandemic to the measures being taken.

You can be assured that we have been working with our Financial advisors at Regions Bank to safeguard to the maximum extent the funds of the Foundation. Our policy has been to invest 40% of those funds in stocks and other equities and 60% in Treasury and corporate bonds. That is a relatively conservative investment policy but is still subject to the volatility in the stock market.

Thanks to the professionalism of our advisors at Regions, The Foundation funds have weathered that volatility relatively well. At this writing, our total investment is down about 5% from the peak before

COVID-19 began affecting our economy. For those who have retirement funds invested, I think you can understand that 5% is an excellent result. WE have optimistic that when the economy recovers from COVID-19, we will find ourselves in better financial condition than six months ago.

That makes two things that you can count on with The American Legion of Iowa Foundation. You can depend on us to safeguard the funds that you have donated and you can depend on the Foundation receiving more requests for funds than we can fulfill and that the Board of Directors will work hard to make sure we fulfill the grants that most closely mirror the four pillars of The American Legion.

When we can hold the annual meeting and make the decisions required for the next year, you will be informed of those decisions. Every one of the \$2.1 million that the Foundation has invested originally came from a member of the Legion family or a Legion supporter. We pledge to you to be transparent in our actions and responsible in managing the funds entrusted to us. Be safe and we will get through this together.
