I want to congratulate all the Post and District Officers taking on new positions this year. Those of you who accepted the challenge of leadership are now tasked with planning your upcoming year. One of the programs offered at Department is our Leadership School this spring. Please find time to attend. It is a rewarding time.

Blue Water Navy law and Decision on Nehmer

On June 25, 2019, Public Law 116-23, Blue Water Navy Vietnam Veterans Act of 2019, was signed into law. This law went into effect on January 1, 2020.

The new law:

- Expands the presumption of exposure to Agent Orange to Veterans who served on vessels operating not more than 12 nautical miles seaward from the demarcation line of the waters of Vietnam and Cambodia, between January 9, 1962, and May 7, 1975. The law may also qualify these Veterans for a presumption of service connection. To be entitled to disability compensation benefits, these Veterans

must have one or more of the conditions associated with Agent Orange exposure.

- May allow previously denied claimants whose claims are granted under PL 116-23 to be eligible for a retroactive effective date.

- Moves the start date to be eligible for a presumption of service connection based on herbicide exposure in the Korean Demilitarized Zone from April 1, 1968 to September 1, 1967.

- May provide benefits for spina bifida (except spina bifida occulta) to children of Veterans with covered service in Thailand between January 9, 1962 and May 7, 1975.

On November 5, 2020, the United States District Court for the Northern District of California held that, pursuant to the Nehmer Consent Decree, VA must automatically re-adjudicate previously filed claims based on Blue Water Navy Veterans' (BWN) presumed exposure to Agent Orange. The court's decision requires automatic re-adjudication in such

cases without requiring a new claim, and potentially paying benefits to the estates of deceased Veterans.

Beginning in April 2021, VBA is sending letters to BWN Veterans and survivors who have a previously decided claim involving the Veteran's or survivor's entitlement to benefits for one or more Agent Orange-related presumptive conditions.

"The Department of Veterans Affairs (VA) will review previously decided claims that may qualify for retroactive benefits for Blue Water Navy (BWN) Veterans who served offshore of the Republic of Vietnam. Veterans and survivors who were previously denied entitlement to benefits based on an Agent Orange-related presumptive condition will automatically have their claim reviewed."





the officers for those things to happen. TOGETHER EVERYONE ACHIEVES MUCH MORE.



These Remarkable young people from 6th District are succeeding at high levels. Congratulations on representing 6th District at State and National levels.




As I leave this position of District Commander, I must say it has been an honor and a pleasure to have served "SECTION 8" these past two years. Although

CALL FOR**THE ONE-HUNDREDTH ONE ANNUAL CONVENTION
THE AMERICAN LEGION, DEPARTMENT OF IOWA**

The One-Hundred and First Annual Convention of The American Legion, Department of Iowa, will be held in Des Moines, Iowa, July 9, 10, & 11 2021. The Convention will be called to order at 4:00 p.m., Friday, July 9, in Ballroom Central and South of the Holiday Inn Airport Conference Center in Des Moines, Iowa.

PURPOSE

The Convention is called for the purpose of:

1. Electing Department Officers for the ensuing year;
2. Ratification of Constitution and By Laws;
3. Selecting the place of holding the One Hundred and Second Annual Department Convention;
4. Selecting delegates and alternates to the One-Hundredth and First Annual National Convention; and
5. For the transaction of such other business as may be brought before the Convention.

REPRESENTATION

Representation will be by Post. Each Post is entitled to two delegates and two alternates, provided it has at least 15 paid up members by June 9, 2021. Each Post is also entitled to one delegate and one alternate for each additional 50 paid up members or a major fraction thereof, whose dues have been paid on or before June 9, 2021.

The vote of each Post will be equal to the total number of delegates to which it is entitled.

All Past Department Commanders of the Iowa Department of The American Legion, who are members in good standing in any Post in the Department, present and in attendance at the Department Convention, shall be entitled to all the privileges of a delegate to said convention, and entitled to a vote therein.

SELECTION OF DELEGATES

All Post delegates and alternates to the Convention will be selected at a regular meeting of the Post, or a special meeting called for that purpose.

Post Adjutants should give notice in writing to each member of the Post of the date, time, purpose, and place of such meeting, and the number of delegates to which it is entitled in the Convention.

Alternates have power to vote only in the absence of delegates, but have all other privileges of delegates.

Delegates should be chosen with care as they have the voting power of the Post on all questions brought before the Convention.

EXPENSES OF DELEGATES AND ALTERNATES

Expenses of delegates and alternates who attend as Post representatives must be paid by their Post or by themselves, as no authority exists for the Department to pay the expenses of any delegate to the Convention.

Each delegation may have as its guests such members of The American Legion and their families as it sees fit to invite to accompany it. Insofar as space will permit, they will be admitted to the Convention Hall.

Press representatives accompanying delegations will be accorded every facility for their work at the Convention. They should report to

the Department Headquarters office upon arrival.

DEPARTMENT HEADQUARTERS

Department Headquarters will be in Room 298 of the Airport Holiday Inn, Des Moines, Iowa. Regular and routine correspondence should be sent as usual to the Department Headquarters, 720 Lyon St., Des Moines, Iowa 50309.

REGISTRATION AND HOUSING

Delegates, alternates and guests attending the Convention must register. A \$10.00 registration fee will be collected from all delegates, alternates and guests at registration.

Delegates, alternates and guests attending the Convention should address all inquiries relative to hotel reservations directly with the designated convention hotel(s).

CREDENTIALS FOR DELEGATES AND ALTERNATES

Credentials for delegates and alternates based upon the number to which each Post is entitled will be given at registration. All delegates, alternates and guests will be required to wear their badge in order to gain admittance into the Convention Hall.

OFFICIALS

Present Department and Post Officers, members of the Department Executive Committee, except Past Department Commanders, Officers of District and County organizations, unless selected as delegates and alternates to the Convention by their Post, have no privileges in the Convention except as guests of their respective delegations.

It is suggested that these officials be made members of the official Post delegation, as their experience will be exceedingly valuable to the delegation.

RESOLUTIONS

Any Post or accredited delegate to the Convention may submit resolutions embodying constructive suggestions for the welfare of The American Legion. They should be in duplicate, typewritten, and shall be turned into the Department Adjutant on or before June 24, 2021, in order that he may refer them to the Resolutions Assignment Committee. A Resolution form with instructions is enclosed. More can be obtained by contacting the Department Adjutant.

CONVENTION COMMITTEES

Friday, July 9, 2021, 1:00 p.m.

Special rooms will be provided for these committees. Time and place of future meetings of the Convention Committees will be set at the first meetings.

DISTRICT CAUCUSES

Saturday, July 10, 2021, 2:00 p.m.

District caucuses will be held at 2:00 p.m. Special rooms will be provided. The Districts will conduct such business as may properly come before such caucuses.

The 100th Annual Department Convention of the American Legion Auxiliary, Department of Iowa will be held Friday, Saturday and Sunday, July 9-11, 2021. All Auxiliary Pre-Convention Meetings, General Sessions and Joint Meetings with The American Legion Family will be held at the Airport Holiday Inn, 6111 Fleur Dr., Des Moines IA.

PURPOSE:

The convention is called for the purpose of electing officers for the ensuing year, amending the Department Constitution, Bylaws, and Standing Rules, receiving reports from Department Officers and Committees, electing delegates and alternates to attend National Convention, receiving reports from members of National Committees, and the transaction of such other business as may be brought before it.

REGISTRATION:

Registration will be Friday, July 9th, from Noon to 3:00 p.m. and 5:00 p.m. to 7:00 p.m. and Saturday, July 10th, from 8:00 a.m. until 11:00 a.m. Pre-Registration is requested online or by mail (covid protection) and the fee is **\$10.00** for all attendees. There is no registration fee for Junior Auxiliary members, but they **MUST** check in at registration table. **Everyone is required to register for the Convention. You must check in at the Auxiliary Registration Table at the Convention.**

REPRESENTATION:

Refer to page 5 of the 2020-2021 Department Blue Book, Article VIII of the Department Constitution, Sections 2, 3, 4, 5 and 6:

Section 2. Each Unit shall be entitled to elect one (1) delegate and one (1) alternate, and one (1) additional delegate and one (1) additional alternate for each fifty (50) members or major fraction thereof, provided their current dues have been received by the Department Executive Director by MAY 15th of the current year. No alternate shall be entitled to a vote unless seated as a delegate.

Section 3. Members of the Department Executive Committee, all Past Department Presidents, District Presidents-elect, and incoming County Presidents, all of whom are in good standing in their local Units, shall be delegates at large to the Department Convention.

Section 4. Election of officers shall be held according to the Department Standing Rules. No member shall have more than one (1) vote.

Section 5: The Legislative Body of this Department shall be the delegates to the Department Convention to be held each year not less than two (2) weeks prior to the National Convention.

Section 6. A quorum of the Department Convention shall consist of fifty percent (50%) of the duly registered delegates.

DELEGATE AND ALTERNATE CREDENTIALS:

A form to list Delegates and Alternates is included in the packet (sent to the Unit President of each Unit by May 31, 2021). This form, listing the Delegates and Alternates, **must be** in the Department Office by no later than **July 1, 2021**. If you are not sending any Delegates or Alternates, please send the form in and indicate there will not be any Delegates or Alternates from your Unit.

Delegate/Alternate ribbons will be issued at the Department Convention Registration table.

A member's name must be on the list provided by her Unit to be a Unit Delegate or Alternate.

If a member of your Unit fits into one of the following categories, please list name and title on the Delegate/Alternate form. They will receive their Delegate ribbon at Department Convention. We need this information for delegate strength.

Department Color Guard Competition

The Department Color Guard Contest will be held on Saturday, July 10, 2021 at the Department Convention. Rules and entry forms are available on the Department website or by request from Department at 800-365-8387. Each entry form must be certified by the Adjutant of the unit's sponsoring Post or District. The contest entry form must be submitted to the Department before the close of the Color Guard Registration Meeting at Department Convention. Advance registration is encouraged and may be submitted to: The American Legion of Iowa, Color Guard Competition, 720 Lyon Street, Des Moines, IA 50309. Order of appearance in the contest will be in reverse order of receipt of entry form with earliest postmark.

The American Legion Department Color Guard Contest does not limit the number of units allowed to compete in the Contest from any Post, Unit or Squadron. All color guard members will be required to register for the Department Convention as a delegate, alternate or guest with The American Legion, American Legion Auxiliary, or Sons of The American Legion.

The contest has two competition classes, Military Open Class and Advancing/Retiring of Colors Class.

Military Open Class - All units must be members of The American Legion and/or Legion Family (i.e. Sons of The American Legion, American Legion Auxiliary, or American Legion mixed participants). If competing for the Commander's Color Guard, all unit members competing in this class must meet all the requirements for full American Legion membership and be over 18 years of age. The unit must be composed of seven (7) members or less including the Commanding Officer.

Advancing/Retiring of Colors Class - All units must be members of The American Legion and/or Legion Family (i.e. Sons of The American Legion, American Legion Auxiliary, or American Legion mixed participants). The unit must be composed of not less than four (4) members. If the color guard consists of only four (4) members, the American Flag bearer will give all color guard commands.

To be considered for the official Department Commander's Champion Color Guard of The American Legion, those units consisting of full Legion members must have competed in Military Open Class.



The American Legion of Iowa Foundation Iowa Legionnaire Summer 2021

The 2021 annual meeting of The American Legion of Iowa Foundation was held as this issue of the Iowa Legionnaire was entering the editing process. As has always been the case, our Board of Directors were tasked with making decisions on applications that far exceeded the funds available. Thanks to the good work of our financial advisors at Regions Bank, we had \$108,000 available for distribution this year, the largest amount ever.

While we thank the professionals at Regions Bank, it is really the generosity of the Legion family and their supporters in Iowa that have made this possible. We would have no money to invest or grants to award if it weren't for you. COVID-19 put a lot of uncertainty in everyone's lives last year resulting in a dip in donations. That

uncertainty is giving way to generosity as we have already received more in donations so far in 2021 than in all of 2020.

Over the last decade, the goal of the Foundation has been a principal value of \$2,000,000. In the last few years, that goal has been met and exceeded. Our quarterly report ending March 31, 2021 shows a total market value of nearly \$2,500,000. After consideration at the annual meeting, the Board has set a new goal of \$3,000,000. That will take some work but so did \$2M and we got that done.

The Directors each have two books of raffle tickets for sale. Prizes in this raffle are not the normal cash prizes but are Iowa Lottery scratch tickets. First prize \$600 in scratch ticket, 2nd prize is \$300 and third prize is \$150. There will be additional prizes. The drawing will be held at Department Convention this summer. Ticket price is \$10. The winner can, of course, choose a cash prize but why turn down the fun of scratch tickets.

Two of our Directors are also planning fun events that will benefit the Iowa Foundation. Larry Swann and his 1st District team have another golf outing planned for June 14. They will have 29 teams playing this year. Last year's outing resulted in a check to the Foundation for \$5,000. Larry also hosted a reception for the grant recipients in the 1st District. Great new ideas.

Riders from all over the state have begun planning a "bug" run to benefit the Foundation. We will leave it to the reader to visualize what a "bug" run may be. It will also involve stops at the Freedom Rocks around the state. This event is still in the early planning stages so keep your eyes open for dates and locations.

The list of grant recipients will be published in a later issue of the Iowa Legionnaire. Read through that list and ask yourself, "Who in our area is doing the kind of work that the foundation supports?" Identify them and encourage that organization to apply next year.

The Foundation's portion of the Department website will be expanding. We want you to know more about our grant recipients and what they do, more than just their name and a one-line description. We want you to know more about the history of the Foundation. We want you to know more about our donors and why they are generous toward the Foundation. Those changes will be accomplished in the next few months.

Thank you to our donors and supporters. Thank you to those wonderful people that do the work here in Iowa that we support. Thank you to Headquarters staff, John, Teresa and Ann that maintain the records and do so much of the work that makes the Foundation possible.

Celebrate Lou Gehrig Day

The American Legion will honor New York Yankees great Lou Gehrig through its American Legion Baseball program, in conjunction with Major League Baseball's creation of an annual tradition of observing Lou Gehrig Day on June 2.

American Legion Resolution No. 6, adopted by the American Legion's National Executive Committee on May 5, 2021, strongly encourages "every American Legion Baseball team to observe a moment of silence before their game(s) each year on June 2 in

memory of Major League Baseball's great Lou Gehrig and all veterans who suffer or have died from ALS." In 2008, the Department of Veterans Affairs (VA) established ALS as a presumptive military service-connected disease. This allows veterans with ALS to be eligible for service-connected benefits. For reasons as yet unknown, veterans are twice as likely to be diagnosed with ALS than the general population.

On June 2, please join us in a moment of silence in honor of Lou Gehrig and all the veterans whose careers and lives were cut short by ALS.

Airborne Hazard Exposure Presumptive Conditions

VA presumes that certain disabilities were caused by military service. This is because of the unique circumstances of a specific Veteran's military service. If a presumed condition is diagnosed in a Veteran in a certain group, they can be awarded disability compensation. The Secretary of VA passed a new rule adding presumptive service connection for three new respiratory health conditions associated with exposure to fine, particulate, airborne matter for Veterans that served on active military, naval, or air service in the Southwest Asia theater of operations during the Persian Gulf War and where the conditions manifest within ten (10) years of separation.

The Southwest Asia theater of operations refers to Iraq, Kuwait, Saudi Arabia, the neutral zone between Iraq and Saudi Arabia, Bahrain, Qatar, the United Arab Emirates, Oman, the Gulf of Aden, the Gulf of Oman, the Persian Gulf, the Arabian Sea, the Red Sea, and the airspace above these locations.

In addition, for purposes of this ruling, this includes a period of active military, naval, or air service on or after September 19, 2001, in Afghanistan and Uzbekistan.

The new conditions are asthma, rhinitis, and sinusitis. Veterans and survivors are encouraged to submit claims.
