
#### SAL Committee Chairman's Report 10/16/24

# Veterans Affairs & Rehabilitation Commission Benefits Committee

I recently attended the 2024 Fall School of the Iowa Association of County Commissioners and Veterans Service Officers, held in Altoona.

Service Officers were presented with information about the Iowa Veterans Cemetery, Iowa Trust Fund and guidelines for Allocation Funding. IDVA maintains databases for DD 214's, Graves Registration and Nursing Homes. This information helps veterans and families get benefits. Dr. Kelly Cook discussed C&P hearing exams and how to prepare your veteran for an accurate evaluation. Caption Call provided information on no-cost captioning phone service, for home or cell phones. Central Iowa VA Healthcare discussed eligibility updates and Post 9/11 Transition and Case Management.

County Offices are still very busy with PACT related claims. Record levels of compensation are being awarded. This keeps our Service Office and VA Benefits Administration very busy, too.

The Committee will be accepting applications for the Val Likens Service Award through Mid Winter Conference. If you have an outstanding service officer, please nominate them.

Our recommendation for filing compensation and pension claims is to use County Veterans Service Officers to organize and file the claim. Gather evidence on the local level, and then forward the claim to Shane and his staff at the American Legion Service Office in the Federal Building. We feel this makes the best use of available services.
