Iowa is Currently sitting 32nd in the National Standing at and 5th in the Midwest Region. As of May 29th.

Iowa's 2025 Year end goal is 5,264. Needing 416 to 100%. The State of Iowa currently is sitting at 4,970, which is 94.41% of their goal and Iowa has an 85.80 renewal rate.

Iowa has 18 possible squadron closures. 33 possible squadrons.

Iowa has 3 new Squadrons West Point Chartered on October 18th. Blue Grass Chartered on October 15th and Delhi Chartered on October 25th. Delhi is having their chartering ceremony on June 14th. At 10:30am Churdan # 198 paperwork was submitted 5/27/25.

DEC Executive meeting was held on 5/22/25 to join the Department of Iowa American Legion and the American Legion Auxiliary in donating \$100 to the Iowa Veterans Home in Marshalltown Mega Bingo game on July 15th, 2025; motion carried.

Lake Park # 371 submitted paperwork to DEC May 27th, 2025, for closure.

17 squadrons are charter only. 10 squadrons are at zero.

Iowa currently has 52 squadrons at 100% or better

Veterans Affairs & Rehabilitation Commission Benefits Committee

I recently attended the 2025 Spring School of the Iowa Association of County Commissioners and Veterans Service Officers, held in Altoona.

Service Officers were trained using peer training and small group discussion to increase participation and discussion. They worked through building a claim, receiving the decision and advising the veteran. Amy Kretkowski, Iowa Law Professor, discussed changes and the appeal process. They also covered reporting to the County and State about the office work.

As I attended Veterans Day on the Hill, January 22nd, I reflected on how far Iowa has come in the area of veteran's benefits, over the past several years. Yes, we have more to do. Included in the top Priorities of the Iowa Commission of Veterans Affairs, was Property Tax Relief and support for Veterans Service Organizations. A few years ago, neither of these would even be considered. My sincere appreciation goes to those who work legislative issues. I have always heard that if you are not telling your story, the other guy is telling his. Meaning that we need to keep telling legislators why it is good to maintain and improve benefits for those who have served this great nation. I urge you to communicate with your state legislators, letting them know you support these initiatives. Whether you attend legislative briefings in your own area or talk the legislators yourself. Let them know you care about veterans benefits in Iowa.

Our recommendation for filing compensation and pension claims remains to use County Veterans Service Officers to organize and file the claim. Gather evidence on the local level, and then forward the claim to Shane and his staff at the American Legion Service Office in the Federal Building. We feel this makes the best use of available services.
