Welcome Legionnaire

On 20 July 2023, Commander Elliot, Tim McLaughlin and I went to the Iowa Veterans Home in Marshalltown, to assist in a Membership Rally. They added 18 New members.

27-30 September 2023 Our Commander, Adjutant I and a few of our District Commanders attended the National Membership Workshop in Indianapolis. 22 September the Commander Elliot, Adjutant Derner and I met with Dan Seehafer candidate for National Commander. He and his staff presented us with a Department goal of 35,204 for 2024 membership year. He also emphasized that our Department work hard on our Post 729 list.

On 5 August 2023, Helped at Camp Dodge on Retirement Information Day, we talked with several Guard retiree and several Enlisted members. We collected 12 new members for our efforts. A good day.

On 14 August 2023, worked the booth at Iowa Fair Veterans Day, we talked with several Veterans and collected 5 new members, even a Vet from Texas.

On 19 August 2023, Department Membership meeting was held, we discussed what we talked with candidate for National Commander Dan Seehafer and his push to work on Post 729.

- 1. We passed the National goal on to the District Membership chairs and their District Commanders, each had to distribute 126 members per District.
- 2. We discussed the Department Commanders incentive. Have your dues paid by 31 December 2023 and your name will be added to a drawing. On 8 January 2024, 8 member's names will be drawn and receive \$250. Each.
- 3. We discussed an incentive for the Post who reach 100% by 1 May 2024. They will be entered into a drawing and 6 Post will receive \$500. each for hitting 100% membership.

Also on 19 August worked a booth in Mineola Ia. Had "Be the One" information out on the table and talked with several people about what the American is do/ working on in Veterans suicide.

On 22 September 2023, email was sent to the Membership committee, explaining that we did not get the National Vice Commander for 15-18 November 2023. I asked for their opinion and a vote on canceling the NCV Tour in November, vote was unanimous to cancel.

Legion Riders Committee Report – Fall DEC October 2023

In 2023, the Legion Riders have seen an expansion beyond all expectations. Chapters are forming in Dows and Pella, Farmington and Goldfield, and there are more inquiries beyond that. I attribute that to each of you here, and to the Legion command staff of the last 2 years. As I move into my 3rd year as Riders Chair, I've known that I have both the support and the encouragement to do that needs to be done to succeed.

The 2023 Department Legacy Ride encompassed Riders from all across the state. 6 of the 9 Districts brought their finds to Convention. We took those funds to National Convention where we presented Chairman Clark and Commander Triolia with \$17,378.00.

Your Iowa Riders continue to raise both awareness and support to the Veterans Emergency Fund. I'm proud to say that the Riders have found a purpose. Recently a call was put out for a logo and in one week's time I was able to send several submissions to Department. The chosen design was a professional submission free of charge. Unique and bold, with a single star in motion, it is fitting for the Legion Riders.

I mentioned in June that Department Leadership Training hosted 8 Legion Riders. The interest generated in that announcement has been such that I'm certain there will be Riders attending in 2024. While on the topic of Leadership Training, I was chosen to represent Department at National American Legion College next month. I'm looking forward to the experience and the knowledge that I will receive, as well as the comradery of being part of the class of 2023 for the rest of my Legion career.

Now what would DEC be without my bragging a little about individual Chapters?

My own Chapter, Ames Riders, Post 37 continues to fundraise for their Wreaths Across America project at Ames Cemetery. Their WAA committee is made up of volunteers from all 3 families and has included Ontario Cemetery as well as Ames Municipal Cemetery bringing the wreath count to over 1800.

Waukee Riders, Post 737 held their 13th annual Toy Run event. Each year they set out to help their community and this year raising \$1500 on this one event that will go towards the sponsoring of local Military families struggling at Christmas.

The Le Mars Riders Chapter 241 were gifted with a donation from TCC Verizon for \$10,000 to help the Chapter serve local veterans in need. They also held its annual fundraiser, called The Healing Run. This event was extremely well attended by area Riders. The event also included a silent auction of items donated by area businesses and the Riders themselves. Partnering with the Sons of the American Legion Squadron 241 of Le Mars who provided the meal at the end of the ride, the total NET income from this event was just under \$9,000. Disbursement of these funds has already begun. The Chapter rode to Sioux City and presented gas cards to a Navy vet who is undergoing dialysis and has limited funds, as well as providing funds to care for Service dogs of veterans attending a free local picnic.

Farnhamville Riders took part in the Dayton Rodeo parade, and a Waukee Rider organized the Riders inclusion in the State Fair Parade. Riders are part of the committee in Marion that organizes the annual Military Veterans Ball. The Stuart Riders have filled a roster for a golf outing being held tomorrow to help fund their post, Manly Riders continue to hold dinners for their post.

Together, we've stood countless flag lines and honored our veterans and comrades with escorts and processions. We do this as a part of the Legion Family, made up of Legionnaires, Auxiliary, and SAL, that come together under the banner of American Legion Riders.

Veterans Affairs & Rehabilitation Commission Benefits Committee

I recently attended the Fall School of the Iowa Association of County Commissioners and Veterans Service Officers, held in Des Moines. 78 counties attended the training.

I presented to the Val Likens Service Award to Elizabeth Ledvina. She serves Tama County and is an outstanding service officer.

Training sessions that I attended focused on establishing better communication with the VA Regional Officer and establishing more outreach activities with the counties. Secretary of State, Paul Pate, and his staff discussed the Safe at Home project, designed to protect the identity of certain individuals, and the upcoming city and school elections. He encouraged everyone to vote and discussed election security in Iowa. A group from Camp Dodge presented information about transitioning, retirement, family programs and Military Family Life Counseling. ESGR State Chairman, Becky Coady, explained ESGR (Employer Support of the Guard and Reserve) and the services provided to employers and service members to keep all parties in USERRA compliance.

With the implementation of the PACT Act, I am told that many claims for DIC (Dependency Indemnity Compensation) have been filed by widows of Marines who were stationed at Camp Lejeune. Even though the veteran may have never filed or was denied, widows may qualify for benefits under the new rules.

The Committee will be accepting applications for the Val Likens Service Award through Mid Winter Conference. If you have an outstanding service officer, please nominate them.

Our recommendation for filing compensation and pension claims is to use County Veterans Service Officers to organize and file the claim. Gather evidence on the local level, and then forward the claim to Shane and his staff at the American Legion Service Office in the Federal Building. We feel this makes the best use of available services.

"BE THE ONE" program is starting to be utilized in the Iowa City Regional local medical centers. The request from Cesar Emano, Iowa City Regional Volunteer coordinator, is to have volunteers come to the CBOC sites, to prepare and serve coffee to veterans as they attend their appointments. The interaction between the volunteer and veteran is to listen and/or give an opportunity to discuss "what can I do for you" insights.

Also discussed with local veterans as they were attending appointments. The veterans were willing to express personal concerns about services and locations provided. Many were older and needed assistance with the appointment.

The **HEARING** MOBILE UNIT providing local CBOC service is totally a hardship for many to gain entrance. (METAL FOLD DOWN STAIRS) no ramp available. The Unit schedule is for many different locations and appointments are limited for access. During inclement weather unit can be out of service indefinite at times. Appointments are cancelled and need to be rescheduled. Worse happening for the veteran if hearing aide breaks it is MAILED in and veteran can be without device well over a week.

Veteran basic **Vision** services are limited in many of CBOC locations as well. The veteran may need simple adjustments or if glasses need to be replaced for minor vision change the veteran goes to lowa City VA Regional. This can be a hardship in traveling long way when a local visit could have met the requirement.

The final service at the CBOC location super helpful for the older veterans would be **PODIATRY** to ensure proactive services to care for their hands and feet.

The recommendation the VA PROPOSAL - create a travel team of MEDICAL Personnel for each concern (Hearing, Vision, Podiatry). Assign and travel to FOUR CBOC sites with the fifth day to review the services provided, team meeting and create next schedule.

Health Administration will conduct Person VISITS to medical sites prior to Mid-Winter Conference to meet with their administration.

Legislative Commission Report, Oct 28, 2023 to the DEC

The Legislative Commission met on Sept 20, 2023 via Zoom.

Attending was Randy Johnson, John Derner, Dave Rehbein, Don DeKock, Nick Lucy, Dwight Dinkla, Elizabeth Ledvina, Dennis Soppe, Nick Laning, Threase Harms, and Stan Elliott.

Quick recap on the Dept of Iowa priorities for last year. We had a highly successful year at the statehouse!

The USS lowa was a one time allocation last year and **was not** on the American Legion priority list for this session.

Legislative wins:

- More than doubled the Military Property Tax Exemption to \$4,000 off valuation. First increase since 1974!
- \$200,000 or 10% increase to the Military Homeownership Program to \$2.2M annually. This will allow 40 more veterans access to the program each year.
- Opposed a couple of pieces of legislation that did not advance

Overall, we had a very positive 2023 for the American Legion agenda at the Capitol.

The Dept of Iowa Legislative Priorities for 2023-2024 are as follows:

- Maintain Funding for the Military Homeownership Program. The Military Service Member Home
 Ownership Assistance Program was established to assist with home purchases for current and
 former military service members who are or have served on active duty. The program helps
 qualified individuals purchase a home in Iowa through matching grants.
- Veterans Treatment Courts. We will continue to urge the State of Iowa to establish and expand more Veteran Treatment Courts.
- Funding for Dept Service Officers at the Federal Building Provide ongoing annual
 appropriations to the state headquarters of the nationally accredited Veterans Service
 Organizations to assist in the operation of Service Offices for the purpose of providing training,
 office support and salaries for Service Officers.
- Training Funds for County VSOs.

American Legion of Iowa Foundation

In the last issue of the Iowa Legionnaire, we told you about two of the larger grants that the Foundation made from our last annual meeting in May. They both went to help very deserving people, one group at the Iowa Veterans Home and the other to the outstanding citizen from Iowa Girls State in 2022 who is now well into her first semester at the US Naval Academy.

This time we want to tell you what has been done to help other veterans with grants. Of course, you know that the lowa Foundation has made grants to several colleges across lowa to help veterans and veteran families enrolled there with their college expenses. Each year that results in scholarships for 20-25 veterans or family members.

Foundation grants have gone to help other veterans also. Standdown events in both Cedar Rapids and Des Moines were assisted with Foundation funds.

Funds were also granted to Iowa Legal Aid (ILA) to help with the work they do assisting veterans with legal problems. While the veteran's privacy is paramount, ILA told us several times they were able to help veterans.

In 2022, ILA was able to help 239 veterans and family members totaling 412 people stabilize their housing situation. These cases were spread all across the state of lowa from Woodbury County to Scott County. Several cases, characterized by ILA as an unusually high number, were referred to the lowa Civil Rights Commission as possible discrimination cases. With the Foundation's financial assistance to get help for these veterans, we may likely have been helping them through the standdowns. Funding the ILA was able to help provide a more permanent solution.

In 2023, ILA closed 699 cases involving veterans. Of these, half involved housing issues with another quarter being consumer matters such as bankruptcy and debt restructuring and 1/10 being family law cases. With help from ILA, those veterans would have been left alone to handle these problems. Without funding the lowa Foundation, ILA would not have been able to help many of them.

22-24 September 2023, Programs Director Eric Less, Boys State Director Dave Schafer and I attended the Americanism Conference in Indianapolis. Discussion held were:

- 1. Insurance, what is covered and what is not, not covered is Transportation, some games, Ninja walls, swimming pools, etc.
- 2. Read your contracts with Police/Trooper involvement
- 3. Read contracts with your Venue (colleges)
- 4. National Judge Advocate, does not read your contracts for you, he asked "what determines what you can and can't do" it depends on where you hold Boys State and the contract, back ground checks need to be done every year.

- 5. SAMSUNG—1995 Started with \$5 million, have given \$7.2 million in scholarship, Fund still has \$7.2 million as of 2023, 2400 students have received scholarship's,
